Signs and Seating Program

Overview

This year the Florida Democratic Party State Democratic Conference will convene at Disney's Coronado Springs Resort, October 27th- 29th, 2017.

As was the case at the 2015 State Convention, this year each delegation (County DEC/State Caucus) is responsible for producing their own delegation sign.

Below you will find the specifications to produce your delegation signage. You are encouraged to contact the FDP Party Affairs office, (Nick Pellito or Rachel Berger 850-222-3411) with any questions you may have.

At 6PM Friday, 10/27, we will hold a Special Training session for Delegation Captains.

Delegation Captains are DEC Chairs/State Caucus Presidents or their designees. It is mandatory that the delegation Captain or their designee attend this training session.

During this training session we will welcome everyone to the Conference and review the electronic voting procedures for Saturday's General session.

Please be sure to make arrangements to attend this training session now.

Sign Specifications

Each delegation (County DEC/ Statewide Caucus) may create 1 delegation sign to represent their organization on the floor of the Delegate Hall during the General Session.

The sign must be freestanding and no larger than 10 feet tall, with a base that that does not exceed 2-3 feet in diameter.

The sign must bear the name of your organization (ex. Palm Beach County DEC/ Miami-Dade/DWCF/ Democratic Black Caucus of Florida).

Your sign should display what makes your delegation unique, and the role your organization plays in contributing to the many facets of our Big Tent Party.

Seating Specifications and Sign Drop-Off

Seating in the delegate hall will be assigned by delegation.

Sign drop off will be from 1PM to 6PM in the Coronado Ballroom on Friday of the convention.

Please drop off your fully assembled sign at this time and it will be placed in your delegation's designated seating area for the General session on Saturday.

Signs will be placed in the aisle just outside of the row where your delegation will be seated.

Signs not dropped off between 1PM and 6PM will not be placed in the ballroom. In this instance, it will be the responsibility of your organization to set your sign on Saturday morning.

Each delegation should be respectful of the needs of their fellow organizations and work to accommodate one another.

Additional Specifications

Your organization is responsible for your sign at all times.

Care should be taken to ensure that your sign does not pose a safety concern and does not become a nuisance or distraction to other delegates or organizations, or take away from the conference.

Signs bearing the names of candidates or campaigns are prohibited.

Signs left unattended, or placed in undesignated areas will be removed.
